



9. Consider and act on resolution of support accepting Round XII Historic Courthouse Preservation Grant from the Texas Historical Commission. (JDC)
10. Review and approve the FY 2023 Holiday Schedule. Take appropriate action. (JDC)
11. Discuss and consider passage of County Resolution FY 23-01, being a resolution for assurance of timely payments for Wise County Claims payment accountability. Take necessary action. (AM)
