The court previously funded a study to look at ground water supplies. Focus was on Parker and Wise due to large growth projections. Goals were to understand the demands, evaluate future supplies and identify big picture solutions for the study areas. Issues are an unsustainable demand on groundwater in growing communities, increased price to connect to public water supply, difficulty connecting to existing supplies, limited alternate supplies, culture for residential water usage, and funding. Method of study was to gather data from the state database, population projections, census data, boundaries and development projections. New developments in the area and the density will be contingent on the ability to source water for the growth. The fear is that with the new growth sourcing water from ground water wells, that the wells productions will drop across the board. Most of the surface water in the county is from the TRWD system. If the county can't meet the future potential water demand, the economical growth will stop.

Possible solutions include:

- > Sourcing additional ground water and possibly brackish water which both offer limited and temporary solutions.
- > The purchase of treated water.
- > Treat raw water purchased from Tarrant Regional and increasing the capacity for treatment with existing companies or a new treatment plant will be necessary.
 - Upper Trinity Regional Water District is willing to upgrade their system but would need treatable water allocated now while still available. A source would need to be created as well.

General implementation plans suggested include:

- Anyone applying for groundwater permits should evaluate the long-term feasibility.
- > Relying on surface water and treating the groundwater as a backup source
- > Water user actions in the short term will include more wells being drilled to meet the demand.
- > Conservation and drought measures would limit and cut back the outside water use.
- > Rainwater harvesting grant programs are in action
- > Aquaphor storage and recovery programs
- > Reuse systems
- > Transition rural areas into public water systems
- > The counties can require groundwater studies
 - Wise county is in a PGMA (priority groundwater management area) which give them additional authority for groundwater studies.
- Enter into inter-local agreements with surrounding groundwater districts to review and oversee the groundwater studies. This allows the groundwater districts to walk the developers and engineers through the studies and then provide recommendations to the court. The possibility of this providing the court with grounds to alter or deny developments would need to be discussed further with legal counsel.
- > Texas does not have a requirement to test water on private wells, however due to the PGMA study, the court may have the authority to require water testing.
- Analysis was done for a new reservoir site on the East side of Wise County along Denton Creek which would bring an accessible surface water source, however there are many obstacles including a significant cost, political obstacles, and treatment supplies, making the feasibility low.

A groundwater survey and review can be done within two weeks to complete the application process.
